The Executive Director's Report

2005 is a milestone for CLC! One hundred three years of operation, 100 years of incorporation and, for me personally, 20 years of wonderful, hard work and love. Every year I see stronger commitment to our mission—serving children and their families. We continually work to improve our programs and remain dedicated to providing the highest quality of early childhood education possible for all families. Our highly trained staff, our first-rate facilities, our committed parents who want the best for their children, and the strong support of the community are the keys to our success.

Accomplishments this year include the development of a second “discovery studio,” which will focus on science and math. This was made possible with the help of GE's Stamford Chapter of Elfun and the Elfun Community Foundation, with support from the Lone Pine Foundation. Every classroom has been or is in the process of being accredited by the NAEYC (National Association for the Education of Young Children)—an accomplishment that fewer than 10 percent of programs across the nation achieve. New playgrounds, successful parent involvement workshops, expanded literacy, science and math Family Nights, and family support programs such as our Fatherhood and Mentoring Program, Learning In A Bag and Reading is Fundamental (RIF) are just

the beginning of a long list of activities and facility improvements that the agency has pursued to enhance our services to our children and families.

To help offset reduced government support and to provide additional funding for growing program needs, we have continued both our awareness campaign to generate broader community understanding of the work we do and our vital fundraising efforts. In September, we honored Pitney Bowes and its CEO, Michael Critelli, as our Corporate Partner in Early Childhood Education. CLC's Alphabet Ball was held in April of this year and celebrated our city's Mayor, Dannel Malloy, and his efforts on behalf of Stamford's youngest citizens. We were delighted to be able to emphasize the importance of providing services such as ours to every child, regardless of income.

The 2004–2005 CLC school year has brought both rewards and challenges. As we conclude this year and make plans for the year ahead, we will remain focused on one goal—giving our young children the high-quality early childhood programs that are vital to their success and that of our entire community.

Who is CLC

CLC began in 1902 as the Stamford Day Nursery, providing care for the children of working families. During World War II, a second center opened for the children of parents in the defense industry. In 1972 the organization became The Child Care Center of Stamford, and in 2002 we changed our name to Childcare Learning Centers – shortened in 2003 to CLC – to reflect our many sites.

CLC is licensed to serve 1,200 children and their families five days a week at 17 locations throughout Stamford and Greenwich. Our mission is to provide comprehensive early childhood education programs for all families and their children, from birth through five years of age. CLC differentiates itself from other early childhood providers by offering comprehensive services, including health maintenance and referrals, nutritionally balanced meals, nutrition education, family social services and parent participation programs.

High-quality, early childhood education for all children provides our best chance to close the achievement gap in our public schools. Safe, reliable care helps children thrive, while enabling their parents to work in the Stamford community. More than 90% of CLC's children come from low-income families, who pay only a portion of the cost of their care. We serve a growing number of special needs children, who require specialized services.

Child Development Program

CLC provides full-day infant, toddler and preschool care for children whose parents are working or in job training or in school, and whose income is at or below 75% of the state median income. A private program is also available.

School Readiness Program

The Stamford School Readiness Program, located at the William Pitt Child Development Center Hillandale Avenue, is a full-day or half-day early care and education program for 3- and 4-year olds.

Head Start

This program is for 3- and 4-year olds whose family income is at or below the federal poverty level. Head Start addresses a wide variety of children's developmental needs: physical, social, emotional and cognitive.

Early Head Start

This is an extension of Head Start, for children under 3 years old and for pregnant women. Classes are very small and designed for children who vary in physical abilities. A home-based program is provided for children under twelve months old.

It has been my pleasure to serve as the president of CLC's Board of Directors during 2004–2005. This year CLC can celebrate countless accomplishments both within and outside of its classrooms. Parents have mastered a new language and are continuing their children's education, from school to home. I can say with certainty that CLC remains committed to enhancing the quality of our early childhood education programs to meet the needs of our community.
